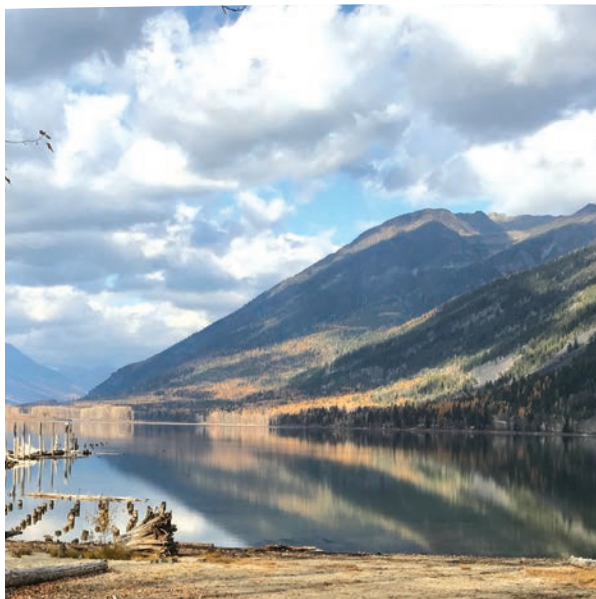

## PARK RULES & REGULATIONS:

1. Park hours are sunrise to 9 pm
2. No overnight camping
3. No liquor or cannabis
4. Dogs must be kept on leash
5. Clean up after your dog
6. Pack out all garbage
7. No parking on the beach
8. Obey traffic signs
9. Park in parking lot
10. Fires in steel fireplaces only
11. Beach area is a protected environmental area  
*Please minimize disturbance*
12. There is no supervision of the beach or water  
*Use at your own risk*
