

REGIONAL DISTRICT OF EAST KOOTENAY

BYLAW NO. 3331

A bylaw to establish a service to provide fire protection to the rural Kimberley area.

WHEREAS under the *Local Government Act*, a regional district may, by bylaw, establish and operate a service;

AND WHEREAS the Board of the Regional District of East Kootenay wishes to establish a fire protection service in the rural Kimberley area within a portion of Electoral Areas C and E;

AND WHEREAS pursuant to the *Local Government Act* participating area approval has been obtained by assent vote;

NOW THEREFORE, the Board of the Regional District of East Kootenay, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited as "Regional District of East Kootenay – Kimberley Rural Fire Protection Service Establishment Bylaw No. 3331, 2024."
2. The Regional Board hereby establishes a service to provide fire protection to the rural Kimberley area within a portion of Electoral Areas C and E.
3. The boundaries of the service area are outlined on Schedule A attached to and forming part of this Bylaw, and the service area is known as the "Kimberley Rural Fire Protection Service Area."
4. The participants in the service established under Section 2 of this Bylaw are Electoral Areas C and E.
5. The maximum amount that may be requisitioned annually for the service provided under Section 2 of this Bylaw shall be \$1.75 per \$1,000 of the net taxable value of land and improvements in the service.
6. The annual costs for providing the service under Section 2 of this Bylaw shall be recovered by one or more of the following:
 - (a) Requisition of money to be collected by a property value tax imposed in accordance with provisions contained in the *Local Government Act*;
 - (b) Parcel taxes imposed in accordance with provisions contained in the *Local Government Act*;
 - (c) Fees and charges imposed in accordance with provisions contained in the *Local Government Act*;
 - (d) Revenues raised by other means authorized under the *Local Government Act* or another Act; and
 - (e) Revenues received by way of agreement, enterprise, gift, grant or otherwise.

READ A SECOND TIME the 14th day of June, 2024.

READ A THIRD TIME the 14th day of June, 2024.

THIRD READING RESCINDED, AND RE-READ WITH AMENDMENTS the 12th day of July, 2024.

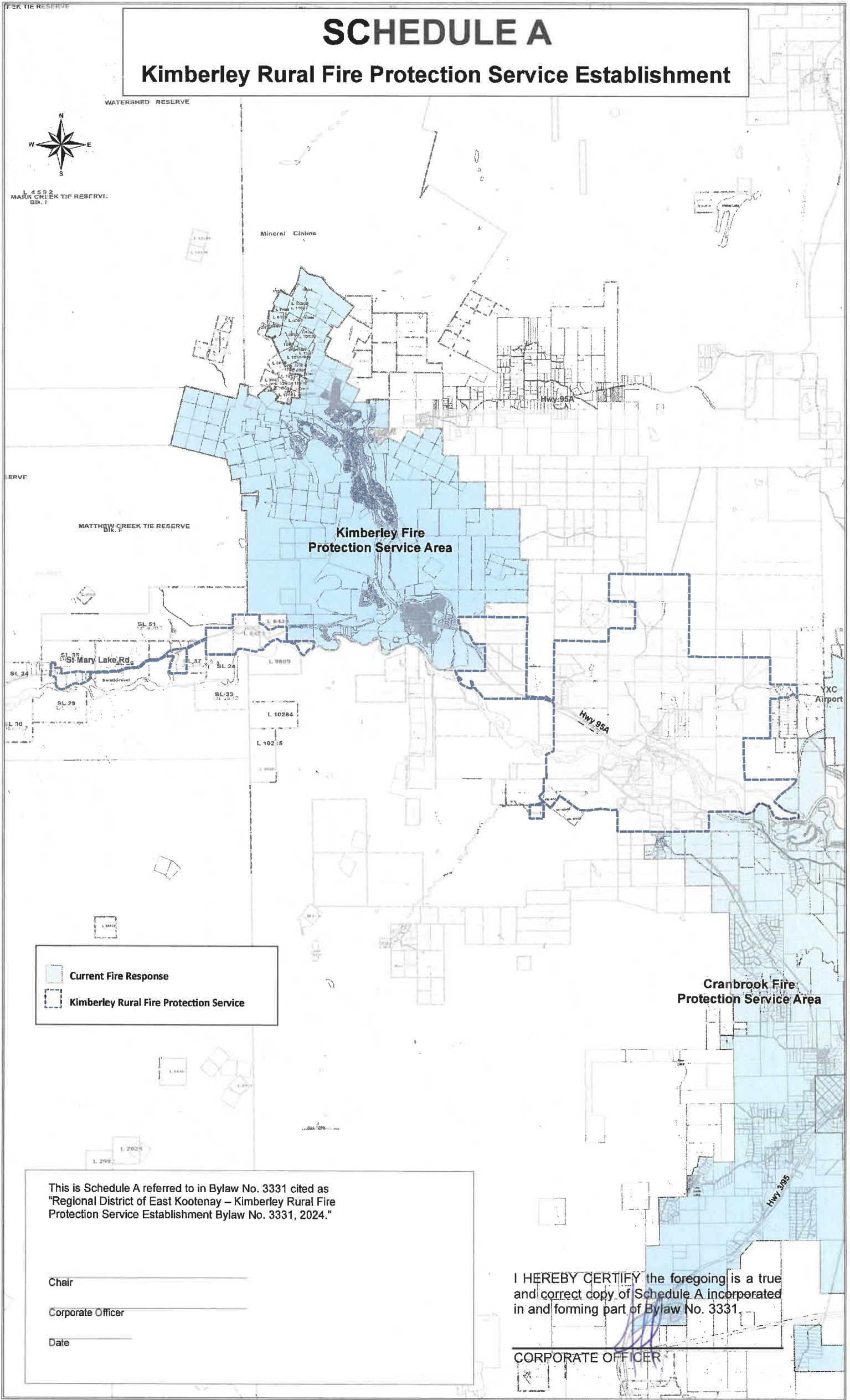
