REGIONAL DISTRICT OF EAST KOOTENAY

BYLAW NO. 2201

A bylaw to impose fees for copies of documents and use of regional district property.

WHEREAS under the provisions of the *Local Government Act*, a regional district may set fees for documents that are available for public inspection and for the use of regional district property;

AND WHEREAS the Board of the Regional District of East Kootenay deems it necessary to impose such fees.

NOW THEREFORE, the Board of the Regional District of East Kootenay, in open meeting assembled, enacts as follows:

- 1. This Bylaw may be cited as "Regional District of East Kootenay General Fee Bylaw No. 2201, 2009".
- 2. Fees shall be charged for documents that are available for public inspection and for the use of regional district property as outlined on Schedule A attached to and forming part of this Bylaw.
- 3. Bylaw No. 1609 is hereby repealed.

2. Meeting Room and Equipment Rental

Meeting room rental – full day \$50.00 (more than 4 hours)

Audio/visual equipment \$25.00
