Columbia Valley Library Grants Policy (44409, 01/14)

1. The RDEK, through the Public Library Grants-In-Aid Service, will provide annual grants to libraries and community reading facilities in the Columbia Valley based on the RDEK five-year Financial Plan.
2. By November 15 of each year, each library or community reading facility may submit to the RDEK a funding request for the immediately ensuing year. The funding request shall include a budget, separately outlining the sources of revenue and nature of operating and capital expenditures.
3. The RDEK Board will review each budget request independently to determine the grants to be included in the five-year Financial Plan.
4. The RDEK will enter into a funding agreement with each library or community reading facility that is to receive funding, and each agreement will include a clause requiring that library services are to be made available to all residents of the Columbia Valley, including the District of Invermere, Village of Radium Hot Springs, Village of Canal Flats, and Electoral Areas F & G, free of charge.
