# East Side Lake Windermere Water Infrastructure Fee

Mark Voszler, Pedley Heights Development Corp, spoke towards The Hideaways at Tegart Ridge, development's project characterization (multi-family vs single family) and projected occupancy, unit size and related water consumption. Mr. Voszler requested the Board's consideration to grandfather the Capital Infrastructure fee charge at \$4,400 until a new servicing bylaw is adopted.
