

RDEK BOARD HIGHLIGHTS

Windermere Treated Water Project Updates

The proposal to purchase Parr Utilities will include the purchase of the building which houses the Water Treatment Plant. The Board has given direction that if an agreement is reached on the sale of Parr Utilities and the building, the method of community assent will by referendum (vote). There will be detailed information coming out to both the Windermere Water Service Area and existing Parr customers once an agreement has been reached and more details are known.

The Board has also authorized staff to submit an application to the Gas Tax Strategic Priorities Fund for the Windermere Treated Water Project. The RDEK application will be for \$6,000,000, which is the maximum that can be applied for through this grant program.

Tie Lake Water Level Control Bylaw Amendment Given Three Readings

The Board has given three readings to an amendment to the Tie Lake Water Level Control Local Service Establishment Bylaw. The amendment increases the maximum requisition for the Service Area to cover the cost of the Tie Lake Dam Upgrade Project. The Project has received approximately 80% funding through the Community Works Fund. The Bylaw Amendment will now be sent to the Inspector of Municipalities for review and approval. If approved, it will come back before the RDEK Board for adoption. The dam must be upgraded to meet regulatory requirements.

Kimberley Rural OCP and Public Hearing

The Board gave Bylaw No. 2760 – Kimberley Rural Official Community Plan first and second reading and authorized a public hearing for 7 PM, Wednesday May 24 at the Kimberley Centennial Hall. The OCP was over a year in the making and takes into consideration the input and advice of area residents and other stakeholders in the plan area. Rural OCPs provide long range and strategic guidance for land use conservation and change in the area covered by the plan, and are usually reviewed by the RDEK every five to fifteen years. If adopted, the new OCP will replace the previous OCP for the area which was completed in 2006.
