## **COLLECTIVE AGREEMENT REACHED**

The RDEK and CUPE Local 2106 have ratified a five-year collective agreement that runs Jan 1, 2023 through December 31, 2027. The agreement focuses on two key areas: addressing the recent high inflation and cost of living increases, and employee wellness. The package includes wage increases that match the BC Consumer Price Index (CPI) in each year of the agreement along with updates to extended health benefits, two wellness days annually, and an adjustment in the flexible work schedule to a two week rotation from a three week rotation.

## **GROWING COMMUNITIES FUND ALLOCATION**

The Board has finalized the allocation of the remaining \$2,167,000 Growing Communities Funds as follows:

- East Side Lake Windermere Water System Service \$1,462,000
- Edgewater & Holland Creek Water/Sewer \$125,000
- Edgewater Water System \$500,000
- Electoral Area Admininstration Service \$80,000

This is in addition to the \$1,500,000 in Growing Communities Funds that had already been allocated to the Cold Spring Creek Debris Flow Mitigation Project in Fairmont.
