5-Year Financial Plan

The Regional District of East Kootenay Board of Directors has adopted the 2017-2021 5-Year Financial Plan. The 2017 operating budget is \$28.1 million, which represents an overall decrease of \$1,383 from last year. This includes a number of grant-funded items and items that are specific to certain service areas. When those items are set aside, the 2017 operating budget for services shared by most municipalities and electoral areas in the region, represents a 1.8% decrease from 2016. Wasa, Ta Ta Creek, Skookumchuck Mosquito Control Contract Update

The Board has rescinded a resolution made last month and has authorized the Chair and CAO to sign an agreement with Morrow BioScience Ltd. (Morrow) for mosquito control services in the Wasa, Ta Ta Creek and Skookumchuck areas for a five-year term. At its February Meeting, the Board authorized the signing of an agreement with Duka Environmental Services Ltd (Duka); however, before the agreement was signed, it was learned Duka was unable to fulfill the full scope of the contract as laid out in the Request for Qualifications. Morrow has been providing the mosquito control service for the area for 19 years and is expected to sign the agreement with the RDEK later this month.

EarthRite Bylaw Amendments Do Not Proceed

The Board considered the results of the public hearing held on February 22 for Bylaws 2672 and 2673 to amend the Steeples OCP and Zoning Bylaw to permit a light industrial development and commercial composting facility near Mayook and, after some debate, voted not to proceed with the bylaw amendments. In its discussion, the Board noted that the recently completed Steeples OCP did not contemplate new commercial or industrial development in this area and that the local residents were largely opposed to the proposal.
