BAYNES LAKE HYDRANT REPAIRS TO PROCEED

A design for the repair and upgrade of the Baynes Lake Dry Hydrant will move forward after \$6,500 was approved for the project from the Baynes Lake Fire Vehicle and Equipment Reserve Fund. The repairs are required due to the lower lake levels in Baynes Lake creating sedimentation and build up of the existing hydrant. Dry hydrants are non-pressurized pipes installed within a water source that allow fire trucks to draw water for fire fighting.

GRANT APPLICATION FOR TRAINING & EQUIPMENT

An application will be submitted to the Union of BC Municipalities for a Community Preparedness Grant in the amount of \$228,900 for the purchase of new and replacement equipment for the RDEK's Fire Services. If approved, the funding would enhance the resiliency and emergency response capabilities of the Baynes Lake, Edgewater, Elko, Fairmont Hot Springs, Hosmer, Jaffray, Panorama, and Windermere Fire Departments by replacing equipment that has reached the end of its service life, and adding training equipment that could be shared regionally to enhance training and improve response capability.
