BYLAW NO. 2833
FEES

Wycliffe Exhibition Grounds

1. FEES

The following Fees will apply for the use of the Wycliffe Exhibition Grounds and include GST:

(a) Entire Grounds (including all Facilities)	\$700.00/event/day
(b) Main Arena and Stable	\$200.00/event/day or \$25/hour
(c) Henderson Pavilion (includes smaller pavilion)	\$200.00/event/day or \$25/hour
(d) Artha Rose Centre – entire building	\$240.00/event/day or \$30/hour
(e) Artha Rose Centre – kitchen	\$160.00/event/day or \$20/hour
(f) Artha Rose Centre – meeting room	\$100.00/event/day or \$12.50/hour
(g) Rider Drop-In – individual use	\$10.00/day
(h) Rider Drop-In – annual pass	\$100.00/year
(i) Instructors Fee – 1 horse / 1 rider	\$5.00/hour + Rider Drop-In Individual Use or Annual Pass
(j) Instructors Fee – 2 horses / 2 riders	\$10.00/hour + Rider Drop-In Individual Use or Annual Pass
(k) Club Use Fee – outdoor Facilities only (regular use by registered club members) * Includes two bookings/club/week (up to 4 hours/booking). Regular Fees shall apply to additional bookings.	\$20.00/member/year
(l) Yardage Fee – open	\$10.00/animal/night
(m) Yardage Fee – open (registered clubs only)	\$5.00/animal/month
(n) Yardage Fee – stable (see Section 4 below)	\$20.00/animal/night
(o) Yardage Fee – stable (monthly)	\$100.00/animal/month
(p) Camping – associated with yardage (see Section 6.6(4) of this Bylaw)	\$25.00/unit/night
(q) Camping – Associated with booking the Entire Grounds	\$10.00/unit/day
(r) Grounds Set Up Fee	Actual costs + 25%
(s) Dressage Ring, Shower House, Pony Track, Cross Country and Mountain Trails	No Charge

2. PAYMENT OF FEES

A non-refundable deposit of 25% of the Fees (minimum \$25.00) must be paid at the time of application for a Facility Use Permit. The balance of the Fees are due and payable two weeks prior to the date of commencement of the event. Failure to pay the required Fees will result in cancellation of the Facility Use Permit.

3. DAMAGE DEPOSIT

- (a) A damage deposit of \$200.00 per day of the event must be paid at least two weeks prior to the date of commencement of the event. The damage deposit will be refunded provided the conditions set out in the Facility Use Permit and all other conditions under this Bylaw or as imposed by the Manager, are met. In the event those conditions are not met to the satisfaction of the Manager, the damage deposit will be retained to cover costs.
- (b) For uses classified in Section 1(k) of this Schedule, a damage deposit of \$200 per calendar year must be paid at least two weeks prior to the first use of the Wycliffe Exhibition Grounds. The damage deposit will be refunded provided the conditions set out in the Facility Use Permit and all other conditions under this Bylaw or as imposed by the Manager, are met. In the event those conditions are not met to the satisfaction of the Manager, the damage deposit will be retained to cover costs.
- (c) In the event that the costs incurred by the RDEK for clean-up or damage repair exceed the amount of the damage deposit, the Permittee will be responsible to pay the full costs plus 20 per cent (20%).
- (d) The damage deposit may be used by the RDEK to hire security if the need arises.

4. YARDAGE

For Yardage Fees charged in accordance with Section 1(n) above, where the stable is rented, \$5.00 of the \$20.00/animal/night Fee will be refunded if the stalls are cleaned and the waste is disposed of in the proper manner to the satisfaction of the Manager or designate.
