DELEGATIONS

Richard Haworth, agent for Bad Toro Properties Inc., spoke to an application requesting an amendment to the Lake Windermere OCP and Upper Columbia Valley Zoning Bylaw to permit commercial and residential development for six properties that comprise of 24.4 acres on Athalmer Road in the Windermere Area. Mr. Haworth explained aspects of the application have been amended to address concerns raised by staff and area residents.

Director Wesly Graham arrived to the meeting at 3:45 pm.

Richard Haworth, agent for Elkhorn Ranch Ltd., made a presentation and requested a development variance permit to allow a well for proposed Lot 11 to be located on proposed Lot 10 for the next phase of development at Elkhorn Ranch.

Helen Eldstrom, spoke and made a presentation on behalf of the Windermere Community Association in regards to the proposed Bad Toro Properties Inc. bylaws. Ms. Eldstrom explained the Society's concerns in regards to the boat storage facilities on Athalmer Road and that these should reside in industrial areas only, not in tourist corridors.

Jean Horton, agent for Lost Dog Forestry Ltd. and Columbia Valley Recycle Ltd., made a presentation and requested an amendment to the Moyie & Area Land Use Bylaw to permit future subdivision for residential and commercial development in the Lumberton area, southwest of Cranbrook. Ms. Horton explained that if approved, the new zoning will accommodate a fee simple subdivision, creating one lot for existing commercial use, 7 residential lots and a common lot property access route.

Ken & Teresa Litchfield, made a presentation and spoke to their development variance application to permit existing golf net safety fencing erected on their property for protection against errant golf balls damaging persons or property. Mr. Litchfield explained the fencing has been in place prior to 2007 and that he has an agreement with a neighbor to remove a portion of the fence.

Philip & Clare Marshall, on behalf of Earl Grey Lodge, spoke to and presented material in support of a partial release of Restrictive Covenant KM127025 and CA516097 to reduce the width of the tree buffer area along the west boundary of the property. Mr. Marshall explained the land was developed 20 years ago and the covenant was in place to restrict the placement of the lodge and protect trees, and now modifications are needed as trees are near the end of their life, diseased and a threat to public safety.

Jean Horton, agent for Cindy & Nick Postnikoff, spoke and made a presentation to request support of their application to the Ministry of Transportation and Infrastructure to close an unconstructed portion of Regan Road in the Meadowbrook area. Ms. Horton explained that, if approved, the unconstructed road will be rededicated to a different location at the time of subdivision of adjacent lands.
